GCRF COMPASS COMPREHENSIVE CAPACITY BUILDING IN EASTERN NEIGHBOURHOOD AND CENTRAL ASIA: RESEARCH INTEGRATION, IMPACT GOVERNANCE AND SUSTAINABLE COMMUNITIES

The GCRF UKRI COMPASS project is an ambitious UK government capacity-building initiative, aiming to extend UK research globally, to address the challenges of growth and sustainability in the developing countries. Notably, the COMPASS project at the University of Kent, together with Cambridge University as its research partner, seeks to establish 'the hubs of excellence' at the top-level HEIs in Belarus, Azerbaijan, Uzbekistan and Tajikistan, to enable them to act as nodes for knowledge sharing and transfer along the following three dimensions, namely research integration, impact governance, and sustainable communities.

2nd GCRF COMPASS International Early Career Researchers Training School

On February 17-21, 2020 CEEUS has organised an **International Training School for Early Career Researchers on "Good governance and effectiveness of public institutions in Post-Soviet Eurasia"** within GCRF COMPASS Project.

The TS participants have been graduates and PhD students, postdoctoral researchers and practitioners working in/with public institutions from Azerbaijan, Belarus, Tajikistan, Uzbekistan and the UK. During the week have been discussed best practices and development challenges of public institutions (e.g. parliaments, civil service, institutions of government, etc.), and their role and effectiveness in delivering good governance across Post-Soviet countries.

PRaNet is an international project and entails the creation of a university wise network between the University of Bergamo (Italy), ADA University (Azerbaijan) and Université Mohamed Lamine Debaghine de Sétif 2 (Algeria) aiming to deepen knowledge and understanding of the phenomenon of radicalization, development of social inclusion and de-radicalization policies and to provide the improvement of integration, through post-university education activities and academic research.

E-Conference on Radicalisation, Terrorism and Deradicalisation: perspectives from Azerbaijan

On June 18, 2020 Center of Excellence in EU studies has hold an E-Conference on the “Radicalization, Terrorism and Deradicalization: Perspective from Azerbaijan” within Prevention of Radicalization Network (PRaNet) project. The conference has brought together academicians, researchers, practitioners, and graduates to exchange and share their experiences and research results on all aspects of Deradicalization and Radicalization. The conference was built around panel discussion and research work presentations of PRaNet project alumnus.

The first panel had specific focus on the role of education in preventing radicalization and deradicalization, agenda of the international organizations in counter-terrorism measures to address extremism/radicalization of individuals and social inclusion policies of government in preventing radicalization and was introduced by Dr. Anar Valiyev, ADA University Dean of School of Public and International affairs, Dr. Michelle Brunelle, University of Bergamo, Mr. Vladimir Gjorgiyev, IOM Chief of mission in Azerbaijan and Dr. Elgun Safarov, member of Committee on the Elimination of Discrimination against Women Office of the United Nations High Commissioner for Human Rights.

The second panel featured presentation by graduates of PRaNet project, Professionalisation course for civil servants and Marte master program that have featured speeches and discussion on counterterrorism policies of Azerbaijan, reasons for absence of sectarian violence in Azerbaijan, modern terrorism and impact of terrorism on political systems.

The conference is considered to become a premier interdisciplinary platform for researchers, practitioners, and educators to present and discuss the most recent innovations, trends, and concerns, as well as practical challenges encountered, and solutions adopted in these fields.

Regional Energy Security Symposium 2020 – Caucasus



On August 11-14, 2020, CEEUS in partnership with NATO Energy Center of Excellence and Naval Postgraduate School will co-organize the fourth round of 'Advanced Regional Energy Security Symposium-Caucasus'. For the first time the program will be held in an Online format. The Symposium will bring together government officials, representatives of high reputable oil companies, high-ranking officials from Azerbaijan and academicians from USA to discuss energy security and threats to Caspian and Caucasus regions. The Symposium aims to further strengthen regional energy security and resiliency through increased awareness, regional coordination/cooperation, interagency coordination and public-private partnerships. The program is intended for regional Energy Security stakeholders at the field in senior management position.

Online edition of 2nd Level Master Degree Program

From September 2020 within PRaNet Project will be launched Online edition of the Second Level Master Degree program in Prevention and fight against radicalization, terrorism and for the integration policies and international security (MaRTE) conducted by University of Bergamo (Italy) in partnership with ADA University. The post-graduate course lasting one year, aims at creating the professional skills necessary for those who want to address the issues related both to the study, development and evaluation of social policies for interreligious and intercultural integration, and to the prevention of radicalization and violent extremism, including through the study and application of methods of de-radicalization and counter-terrorism strategies.
